WHAT YOU NEED TO BRING	To review your present coverage against what is available for 2010, you will need to bring: A. Your Medicare Card B. Your present Prescription Card (Part D) C. A complete list of all prescription medications you are now taking, including: i. Name of Medication ii. Dosage iii. Number of doses per month NOTE: If you cannot prepare a list, you can bring all your medications.

- Each year the providers of Medicare Part D benefits revise and update their plans. Changes may include:
 - formulary changes
 - medications placed on a different schedule of coverage
 - annual deductible, monthly premium
 - co-payments/co-insurance payments
 - donut hole provisions
- These changes may impact **YOUR** prescription drug costs.
- **YOU** are urged to perform a review of **YOUR** Medicare Part D coverage.
- **YOU** will be able to enroll in your selected plan during a Counseling or Workshop session.

Medicare enrollees who have Medicaid or are in an HMO plan DO NOT have to review their coverage.
